**To: The Creditors of Red Dog Deli Raw Food Company Inc. (the "Company")**

The Company filed a Notice of Intention to make a Proposal (the "NOI") on August 31, 2020, and Crowe MacKay & Company Ltd. (the "Trustee") was appointed as the monitor for the Company. Enclosed please find the NOI, a List of Creditors, Trustee's Consent to Act, and the Certificate of Appointment. As the Trustee, we would like to take this opportunity to address some issues and perhaps answer some questions that you may have.

**The Company has NOT filed for Bankruptcy nor is the Company in Receivership.**

The Company remains under the control of management. The NOI creates a Stay of Proceedings, and allows the Company a period of up to thirty days to prepare and file a Proposal to its creditors unless the period is extended by the Court upon application by the Company.. During this period, the Trustee will monitor the business of the Company and assist the Company in preparing its proposal (the "Proposal").

All amounts owed by the Company as at the date of the NOI will be dealt with as part of any Proposal to be filed by the Company. The Company is continuing to operate as usual during the NOI period. Pursuant to Section 65.1 of the Bankruptcy and Insolvency Act, a supplier is prohibited from refusing to continue to provide goods and services to a debtor.

**Filing a Claim**

At this time, you do NOT need to file a Proof of Claim or report any discrepancies concerning the amount reported as owing to you by the Company, as stated on the List of Creditors enclosed. You will receive a Proof of Claim form to complete and file with the Trustee after the Company has filed its Proposal. All proven creditors will have the opportunity to vote on the Proposal in person or by mail at a creditor's meeting to be held approximately three weeks after the Proposal is filed.




