THIS COURT ORDERS that:



B-3 shall no longer operate in respect of any of the parties to Supreme Court of British Columbia Action Numbers: (a) S-188824 (Vancouver Registry); (b) S-1913985 (Vancouver Registry); (c) S-19790 (Terrace Registry); and (d) S-20005 (Terrace Registry) (collectively, the “**Actions**”), but only to the extent necessary to permit the

Actions to continue unimpeded by the Stay, and the Stay will not prevent or affect the right of parties in the Actions to enforce *in rem*, trust, or other proprietary claims.

3. Endorsement of this order by counsel appearing, other than counsel for the Applicant, is hereby dispensed with.
