ON THE APPLICATION OF Bear Creek Contracting Ltd. (the “**Applicant**”), coming on for hearing by telephone at Prince Rupert, British Columbia on this day, and on hearing Glen Nesbitt, counsel for the Applicant, and those counsel listed in Schedule “A” attached hereto; AND UPON READING the material filed;

THIS COURT ORDERS that:

1. The stay of proceedings (the “**Stay**”) arising pursuant to section 69(1) of the *Bankruptcy and Insolvency Act*, R.S.C. 1985, c. B-3 shall no longer operate in respect of any of the parties to Supreme Court of British Columbia Action Numbers: (a) S-188824 (Vancouver Registry); (b) S-1913985 (Vancouver Registry); (c) S-19790 (Terrace Registry); and (d) S-20005 (Terrace Registry) (collectively, the “**Actions**”), but only to the extent necessary to permit the Actions to continue unimpeded by the Stay, and provided, however, that the Stay shall continue to operate in respect of the execution of any judgments or other monetary awards that may be granted or made against the Applicant in the Actions.

2. These proceedings shall be transferred from the Prince Rupert Registry to the Vancouver Registry for all purposes.
3. Endorsement of this order by counsel appearing, other than counsel for the Applicant, is hereby dispensed with.
