CONVENIENCE CREDITOR ELECTION

TO: Crowe MacKay & Company Ltd., in its capacity as proposal trustee (in such capacity, the “Proposal Trustee”) of Bear Creek Contracting Ltd. (the “Company”)

In connection with the Proposal of the Company pursuant to the *Bankruptcy and Insolvency Act*, R.S.C. 1985, c. B-3, dated June 24, 2021 (as may be further amended, restated, modified or supplemented from time to time, the “**Proposal**”) the undersigned hereby elects to make a Convenience Creditor Election pursuant to the terms of the Proposal.

Capitalized terms used in this form have the definitions given to them in the Proposal, and the following terms are herein defined as follows:

- (a) “**Voting Record Deadline**” means noon (Vancouver time) on July 14, 2021.

If an Affected Creditor completes this Convenience Creditor Election and delivers it to the Proposal Trustee by the Voting Record Deadline, then they are thereafter a Convenience Creditor and:

- (a) on the Funding Date, they will be paid an amount in cash equal to \$500 in full and final satisfaction of their Proven Claim; and
- (b) they will be irrevocably deemed to vote the full amount of their Proven Claim in favour of the Proposal as a member of the Affected Creditor Class, and any proxy filed by or on behalf of such Convenience Creditor, either before or after delivery of this Convenience Creditor Election, shall be of no force and effect and they shall not be entitled to vote at the Meeting.

For clarity: (a) ONLY Affected Creditors having Proven Claims in excess of \$500 may complete this Convenience Creditor Election; and (b) no Affected Creditor may bifurcate or sub-divide their Affected Claim for the purpose of making the Convenience Creditor Election.

If you wish to make the Convenience Creditor Election, pursuant to the terms of the Proposal you must deliver this Convenience Creditor Election to the Proposal Trustee by mail, email or fax so that it is received by the Proposal Trustee by the Voting Record Deadline at the following address:
